- 2. On Schedule 5-E of this report, you have not itemized all of the necessary independent expenditure information. Proper disclosure requires the full name and address of the payee, the date, the amount, the aggregate calendar-year-to-date total, the purpose, the election, and the name, office sought, state, and district of the federal candidate supported or opposed by the expenditure. Please amend your report to include the full name of the payee, the address of the payee, the complete date and the aggregate calendar-year-to-date total. (11 CFR § 109.10(e)(1))
- **3.** Itemized independent expenditures must include a brief statement or description of why the expenditures were made. Please amend Schedule E to clarify the following description(s): "To bring awareness of job losses if Lockheed closes."
