This letter is in response to your request for additional information, dated December 7, 2014, for Sullivan for US Senate.

1. The attached summary pages have been amended to correct the Column B figures and starting cash on hand.
2. The Committee believes that it had an effective procedure in place for reporting those receipts requiring a 48-hour notice, but acknowledges that the contributions listed were inadvertently omitted from these filings.
3. Schedule B line 20a has been amended to reflect the accurate refund to Eugene Kusmiak
4. The letter indicates that the Committee must itemize conduit or intermediary information for each earmarked contributions received. The committee has reported all contributions that met the cycle to date aggregate total of \$200 or more. 


