This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following  $\underline{4}$  item(s):

1. The beginning cash balance of this report does not equal the ending balance of your Mid Year Report (1/1/15-6/30/15). Please correct this discrepancy and amend all subsequent report(s) that may be affected by the correction. (52 U.S.C. §30104(b) (formerly 2 U.S.C. § 434(b)(1)))

**2.** There should not be a gap in the coverage dates of your report. You must file an amended Year End report to include the activity from 7/1/15 to 12/31/15. (52 U.S.C. §30104(b) (formerly 2 U.S.C. § 434(b)))

**3.** Please provide a Schedule A to support the amount disclosed on Line 11(a) (i) of the Detailed Summary Page. Contributions from individuals/persons other than political committees that aggregate in excess of 200 per calendar year must be itemized on Schedule A. (11 CFR 104.3(a)(4)(i))

4. Line 21(a) of the Detailed Summary Page discloses allocated federal/non federal operating expenditures during the reporting period. Committees must itemize each allocated disbursement made from its federal account or separate allocation account regardless of the amount. Please amend your report(s) by itemizing the expenditures on Schedule H4. If the disbursements were for operating expenditures paid for with 100% federal funds, they should be itemized on Schedule B for Line 21(b) of the Detailed Summary Page. If these

expenses were permissibly paid for with 100% non-federal funds, they should not be disclosed on Schedule H4. (11 CFR §§104.10 and 104.17) Please amend your report to clarify this discrepancy.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.

<u>Electronic filers must file amendments (to include statements, designations and reports)</u> in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
