Ct. 876, 913 (2010), the U.S. Court of Appeals for the District of Columbia Circuit decision in SpeechNow.org v. Federal Election Commission, 599 F.3d 686 (D.C. Cir. 2010), and the language recommended in Advisory Opinion 2010-09 (Club for Growth) or Advisory Opinion 2010-11 (Commonsense Ten), it therefore intends to raise funds in unlimited amounts.

This committee will not use those funds to make contributions, whether direct, in-kind, or via coordinated communications, to federal candidates or committees.
