The National Football League donated 55.2 hours of professional staff time (valued at approximately \$10,873.98) this reporting period to ensure compliance with the Federal Election Campaign Act. All of the services to ensure compliance with the Federal Election Campaign Act, that the National Football League donated to the PAC for the period of January 1, 2021, through June 30, 2021, took place between January 1, 2021 through June 30, 2021. The National Football League ('NFL') provided 97 hours of professional staff time (valued at approximately \$11,722.48) with respect to PAC activities such as fundraising and decision making about contributions. All of the services, with respect to PAC activities such as fundraising and decision making about contributions, that the NFL donated to the PAC for the period January 1, 2021, through June 30, 2021 took place between January 1, 2021, through June 30, 2021. As disclosed on prior reports, Gridiron PAC made a \$10,000 in-kind services prepayment to the NFL for non-compliance services on January 31, 2020. \$8,009.81 of that amount remained available as of January 1, 2021. As a result, the net in kind contribution from the NFL to gridiron PAC in this period was \$3,712.67. The NFL is an unincorporated association qualified to contribute to political committees subject to the individual contribution limits of the FECA.
