Enclosed find three amended FEC Form 3X reports for 1996. The spreadsheet used to calculate the Schedule A for the report for the period February 20, 1996 through March 31, 1996 added the year-to-date column, instead of the current column, overstating the itemized contributions. This was not caught in the proofreading stage. This error unfortunately changed the amounts for itemized [line 11(a)(i)] and unitemized [line 11(a)(ii)] contributions. The total contribution [line 11(a)(iii)] amount was correct. This then carried forward to the other reports in the cumulative (Column B) totals. Per our conversation of November 4, 1996 it is only necessary to forward the FEC 3X pages and not the Schedules A showing the change. The corrected Schedule B for the Second Quarter report is also attached, the incorrect box (Primary Election) was checked for this donation was for.


