This letter is prompted by the Commission's preliminary review of the Statement of Organization referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received by the response date noted above.** Additional information is needed for the following 2 item(s):

1. Your Statement of Organization (FEC Form 1) reports information about a Principal Campaign Committee; however, your filing fails to disclose information about the candidate. Commission regulations require that the Statement of Organization disclose the name of the candidate, the office sought (including State and Congressional district, when applicable), and party affiliation of the candidate. (11 CFR 102.2(a)(v)) Please amend your Statement of Organization to include the name, office sought, State and Congressional district, and party affiliation of the candidate.
2. You have failed to include complete information regarding your committee type on your your Statement of Organization (FEC Form 1). (11 CFR § 102.2(a)(1)(i)) Please clarify your committee type by amending your Statement of Organization to disclose the committee type. This can be done in Section 5 "Type of Committee" on the FEC Form 1 by checking one of the boxes labeled (a) - (h). Currently, your committee type is a Joint Fundraising Representative and does not include participant committee information. If your committee is a principal campaign committee of a candidate, please select box (a). Please amend your Statement of Organization to clarify your committee type and provide any additional information requested for the selected committee type.

**Please note you will not receive an additional notice from the Commission on this matter.** Adequate responses received on or before this date will be taken into

consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
