The Treasurer of the Stinson Morrison Hecker Political Actions Committee (PAC), Phillip Fraas has provided exempt legal services during the period of October 1 to 15 of 2014 and the PAC is hereby reporting the receipt of those services as provided for in 11CFR 104.3(h). Following is a description of the value of the time spent in providing the services. Mr. Fraas's employer, Stinson Leonard Street, pays Mr. Fraas primarily based on his receipt of payments from clients for his provision of legal services to them. Since the services being reported here are provided 'gratis' to the PAC and since the firm is not paying him directly for providing those services, the value of his exempt legal and accounting services for the purpose of the report can't be determined by billing or collection on the hours worked in providing those services. However, Mr. Fraas recorded an estimated 83 hours of work in the period of October 1 to 15 of 2014 for which he was paid \$8,300.00 by the firm. And, he spent 1.9 of those hours providing the exempt legal and accounting services. The % of total hours spent on the exempt services comes to approximately 2% and 2% of \$8,300.00 is \$166.00. Thus Mr. Fraas values his exempt services during the period of October 1 to 15 of 2014 at \$166.00
