While preparing our January Year End Report for 2004, I discovered a mistake that traced back to the October 15, 2004 filing. Under answer 11(a) we mistakenly entered the wrong number for the amount of itemized contributions for the reporting period. While all contributions aggregating over \$200 were reported, the total was added incorrectly, thus changing the result for 11(a). Enclosed, please find our amended reports for October's quarterly filing and for the 30 day post election report filed on 12/01/2004. Because of the miscalculation in the October report, the results were also wrong in the post election report, thus necessitating an amendment to that report as well.

We apologize for the mistake, and any subsequent confusion it may have created, and will make every effort to ensure that such errors do not occur again.
