This is a response to an FEC e-mail which I received on October 9, 2014 regarding the Hanson Professional Services Inc PAC (Identification Number C00406124) requesting more information because the PAC may have satisfied the criteria for becoming a multicandidate committee.

After reviewing 11 CFR 100.5(e)(3) as indicated in the e-mail, Hanson Professional Services Inc PAC meets the criteria stated in 100.5(e)(3) parts (i) and (iii) for becoming a multicandidate committee, but it does not satisfy the criteria for becoming a multicandidate committee as defined in 100.5(e)(3)(ii):

"has received contributions for Federal elections from more than 50 persons"

According to our file documentation, the PAC has had 44 contributors since its start date; this is below the 50-person threshold indicated in the regulation.

We will continue to monitor the number of contributors and submit FORM 1M when the committee receives a contribution from its 51<sup>st</sup> contributor.
