

This letter is in response to your letter dated April 12, 2016. There is no amended report associated with this letter.

All contributions for the runoff election have been refunded, and those refunds are reflected on the committee's first quarter 2016 report (filed in April 2016). Your question regarding general election funds is not reflective of Louisiana's unique runoff election system, discussed by the Commission in AO 2000-29. At the time the committee's funds were spent in 2015, Senator Vitter was considered to be a general election candidate under Louisiana law and FEC rules and it was permissible therefore to spend such general election funds.
