- Schedule A of your report discloses contributions from "Athwal Investments LP," "Del Mar Farms," "Delta Orchards LP," "E & H Farms," "Kay-Dix Ranch," "Khera Orchards," "Payne Bros. Ranches," "Ravi & Jay Thiara Farms," and "Smith Ranch" that appear to be from an unincorporated proprietorship or partnership. These contributions should be attributed to each member in direct proportion to his or her share of the organization's profit or by agreement of its members. Each person who has contributed in excess of \$200 since January 1 should be identified by name, address, occupation, name of employer, amount of contribution, and aggregate total as a memo entry on Schedule A. (11 CFR §110.1(e) and (g)) Please amend your report by providing the omitted information.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.
