This amendment is in response to your letter to AMBUPAC Treasurer Tristan North dated December 18, 2002, regarding clarification of a contribution on our 2002 12 Day Pre-General Report which appeared to exceed the limits set forth in the Federal Election Campaign Act. The clarification request pertains to a \$5,000 contribution made to Friends of Max Baucus. The contribution in question provides the appearance of exceeding the limits under U.S.C. 441b(a) as a result of a clerical error made in our October 15, 2000 Quarterly Report. On page 5 of Schedule B of our October 15, 2000 Quarterly Report, we incorrectly marked a \$2,000 contribution to Friends of Max Baucus as a disbursement for the general election instead of the 2002 primary election. Due to the contribution being made just prior to the 2000 elections, it was inadvertently marked for the general election even though Senator Max Baucus was not up for reelection until 2002. On January 2, 2003, we filed a written amendment to our October 15, 2000 Quarterly Report that accurately marked the \$2,000 contribution to Friends of Max Baucus as a disbursement for the primary election. The general election disbursement of \$5,000 reported on the 2002 12 Day Pre-General Report to Friends of Max Baucus is therefore now within the limits set for in the Act.
