Dear Mr. Lanz:

In response to your letter of August 4, 2006 regarding the electronic filing of an amended Statement of Organization for the Principal Life Insurance Company Political Action Committee, following is reply information, as requested in your August 4 letter:

- **Treasurer Signature** – As stated in your letter, the electronically filed Statement of Organization wasn't signed by the individual identified as the treasurer on Line 8 of the form. The Statement of Organization was filed on June 28, 2006 and was signed by James Lang. James served as PrinPac Treasurer from July 1, 2005 through June 30, 2006. My term as Treasurer began on July 1, 2006, as indicated on the Statement of Organization, and extends to June 30, 2007. To clarify, I am currently responsible for fulfilling the official duties of the Treasurer position of PrinPac. As requested, an amended Statement of Organization has been filed under my signature.
- **Type of Committee** – The Statement of Organization electronically filed on June 28, 2006 indicates, in error, that our committee is a principal campaign committee. On Line 5, the statement should have indicated the committee is (e) – a separate segregated fund. The amended Statement of Organization that has been recently filed correctly indicates the committee is a separate segregated fund.

I hope the information above, along with the recent filing of the amended Statement of Organization, adequately addresses all matters set forth in your August 4 letter. 
