

Dear Ms. Kimberly Willis:

Enclosed are amendments reconciling the previous discrepancies in bank loans to the Friends of Tim Johnson campaign as reported in Schedule C of the April 15 and July 15 reports of this year. Please find also enclosed an amendment to Schedule A of the post-general report. We received notification of an in-kind contribution from a federal PAC after the filing deadline.

Regarding missing employee and occupation information of contributors of over \$200, we did indeed expend our "best efforts" to obtain this information. The contribution cards that we sent out with all fund-raising letters and materials solicited the information. If the information was not disclosed with the contribution, a follow-up letter was sent out within four weeks, although usually within two weeks. If no response was received, we again followed up with either an additional letter, or a phone call. All responses were reported to the Federal Election Commission.
