In Schedule E, the payee 'Sierra Club' reported as \$186.61 disbursement for List Rental correlates to the 10/1-3/06 24 hour notice. However, the 24 hour notice reports the List Rental at \$231.60 dated 10/11/06. The difference is due to the fact the 24 hour notice miscalculated the value of the List Rental. Therefore, since the 24 hour notice cannot be amended the disbursement was recalculated to correctly state the value of the List Rental.
