
This letter and attached Form 3 report amendment are a response to a Request for Additional Information (RFAI) from the Federal Election Commission, dated August 26, 2010.

The first item mentioned in the RFAI references "contributions received after the primary election that are designated for the primary." We have verified that all such contributions sent after the date of the primary election were properly designated to reduce net debts outstanding from the primary election. We have also amended our report to clarify this.

The second item states that our committee "may have failed to file one or more of the required 48 hour notices" and cites one contribution in particular. Our review indicates that we filed all 48 hour notices as required. The contribution cited in the RFAI was received through a conduit committee on May 17, 2010, which fell outside of the 48-hour reporting period. The date listed, May 13, 2010, was the date the conduit committee received the contribution.

The third and final item requests clarification of the disbursement purpose description, "research consulting." We have amended our report to provide this clarification.


