Dan Coats for Indiana (FEC ID# C00476374) is in receipt of your Request for Additional Information dated December 30, 2010, in which you reference the reporting of contributions which were marked as 2010 primary or general debt retirement on the Committee's 30-day post-general FEC report (the "Report"):

The Committee does not have net debt for the 2010 general election. The Committee is filing an amendment (a copy of which is enclosed) to the Report, and all donations previously marked for 2010 general election debt retirement are now marked for 2010 primary debt retirement, or for the 2016 primary, as appropriate.

The Committee did have net debt as of the primary election date of May 4, 2010, and was still in a net debt situation with respect to the 2010 primary as of the cut-off date for the Report on November 22, 2010. The Committee has continuously reported the loan received from Senator Coats for the 2010 primary and the corresponding loan repayments, and \$ 176,700 remained unpaid from the loan as of the close of this post-general reporting period.

All donations reported as 2010 primary debt repayments are, as noted in your letter, specifically designated by the donors for 2010 primary debt retirement. Therefore, there is no amendment required with respect to the 2010 primary debt retirement donations disclosed on the Committee's 30-day post-general report.





