We are counsel to the Show-Me Political Action Committee ("Show-Me PAC"). Show-Me PAC filed its original Form 1 Statement of Organization on April 2, 2005.

Your letter dated April 22, 2005, requested clarification of whether Show-Me PAC is affiliated with any other committee or is connected with any organization.
