Please amend your report and any subsequent reports that may be affected by this correction.


-Your calculations for Lines 6(d), Column A and 8, Columns A and B appear to be incorrect. FEC calculations disclose these amounts to be \$119,239.78 and \$103,739.78, respectively. Please provide the corrected totals on the Summary Page.

-The totals listed on Lines 23, 30, and 31, Column B of the Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct

Column B totals. Please amend your report and any subsequent reports that may be affected by this correction.
