


Dear Mr. Henry:

Through the efforts of Wes McAden, your political action committee forwarded campaign checks to our office for two of our clients -- Congressman Gary Condit and Congressman Cal Dooley. Unfortunately, in the crush of last minute filing efforts, our staff inadvertently deposited the check that your PAC had issued to Gary Condit into Cal Dooley's checking account. This mistake was not noticed by the bank.

To rectify this problem, I am enclosing a check from Cal Dooley's account back to your PAC. This check in essence represents a refund of your \$500 check (no. 2044) that you had issued to Gary Condit. We have reflected this as a refund on our FEC filing and have alerted the Condit campaign about our mistake. I hope that you will be able to issue a new check to Gary's campaign.
