Dear Ms. Chamorro,

In response to the request for additional information regarding our amended 12 Day
Pre-General Report, we are expanding on our explanation as follows:

The original Pre-General report was in error due to a data file transfer error. This error
resulted from a staffer's misunderstanding of the deadline for transferring data from our
membership database into our finance system, which provides the aggregate data for
our FEC reports. As a result, the data was not transferred into the finance system by the
22nd of October filing deadline, resulting in an underreporting of total (and unitemized)
contributions for the period. However, the data was transferred by the end of October,
and in preparing our next FEC report, we recognized the error, and filed the amended
report disclosing an increase in receipts totaling \$13,996.50.

Because we report itemized contributions (for individuals contributing in excess of \$200
for the year) based on data from our membership database, the itemized contributions
on the original report were correct. The only contribution data error was the aggregate
numbers for total contributions and unitemized contributions.

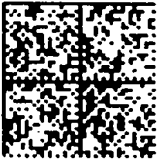

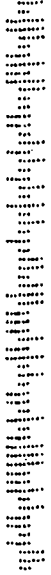
