This letter pertains to a letter you sent the committee on February 10, 2006.


I spoke to you about two weeks ago informing you that we had been trying for some time to upload our response (copy attached) and could not do so (we are an electronic filer). I explained that we ultimately received an FEC Electronic Filing Result that indicated our filing could not be processed. I read you the explanation (copy attached), you said you did not understand it, believed there should not be a problem, and suggested we contact the people in electronic filing.

We called the number several times but only got voice mail. Our call was returned by Stephanie, but not until late in the day on April 6. Stephanie insisted that the problem was with our software (Aristotle) and for that reason, she could not help us. We explained that we talked to Aristotle several times and there was no problem with our software. In fact, we had uploaded response letters several times in the past without a hitch. When we told Stephanie this, she repeated that it was our software that was at fault, that the problem was ours, and she could not help us. We rechecked with Aristotle and they confirmed once again that there was nothing wrong with our software.

We are happy to try again, but it does not seem useful without guidance from the FEC. Additionally, it would be pointless to talk to Stephanie any further. I have attached our response letter. If you can accept this, please let me know. If we still need to file it electronically, please advise how we should proceed. You can reach me by cell phone at 402-212-0914.


Re: Your letter of February 10, 2006
