Dear Mr. Francis:

This letter is in response to your letter of June 24 and John Gibson's follow-up letter of July 17, 1998 to Richard Gunderson, Treasurer of the American Council of Life Insurance PAC. Our FEC ID number is C00147066. You had written pointing out problems in the total amounts reported as having been contributed to Senators Dodd and Faircloth. We apologize for our delay in responding, a delay caused by confusion over Sen. Faircloth's having his 1992 and 1998 committees in existence concurrently.

Sen. Dodd has received a total of \$5000 towards his 1998 General Election campaign and \$1000 towards his 1998 Primary. We incorrectly reported our June 25, 1997 contribution of \$1000 as having been for the General Election. Sen. Dodd's campaign correctly reported it to you as having been for the Primary. I have attached a revised Schedule B reflecting this.

Sen. Faircloth has received a total of \$3000 for his Primary Election and another \$3000 for the General Election. We incorrectly reported the October 16, 1996 contribution for \$3000 and the March 6, 1998 contribution of \$1000 as having been for the General Election. Sen. Faircloth correctly reported them as being for the Primary Election. I have attached a separate Schedule B reflecting these corrections.
