This office has reviewed our Year End Report (10/01/05-12/31/05) submitted to your agency. This review process was prompted by your recent letter requesting clarification of certain line items within the report.

### SCHEDULE A SUPPORTING LINE 11(a)(i) (Itemized Receipts)

Contribution totaling \$5,971.62: On November 30, 2005, Bank Midwest, Local 533's primary banking institution, deposited \$3,045.00 in error to the Volunteer Political Fund. This error was brought to the attention of banking officials,

with the request that this deposit be backed out of the Political fund and moved to the correct account. Rather than back it out, Bank Midwest again credited the account \$3,045.00. These two deposits had to be reported, since they were still in the account at close of business December 31, 2005. A debit for \$6,090.00 was effected January 6, 2006, and will be reported on our 1st Quarter 2006 Report. Another deposit of \$118.38, deposited in error as member contributions,

was transferred out of our account by debit on December 22, 2005, bringing the total for this line item to \$5,971.62 (\$3,045 + \$3,045 - \$118.38). None of the three transactions in question were contributions to our PAC fund. They were simply bank errors/corrections.
