On 11/25/08, general journal entry dated 12/31/01 was discovered. The entry included outstanding checks prior to 2001 in the total amount of \$8100. Details of the checks are as follows: #6 - Jaime Espanza \$1000, #16 - Robert Jarvis \$1500, #1028 - Ken Mayfield \$1500, #1000 - Texas Ethics Commission \$100, #1002 - Billy Joe McCoy \$1000, #1047 - Velleta Lill \$2000, #1052 - Velleta Lill \$500, and #1060 Don Hill \$500. Upon review of the transaction history, those checks were found to still have not yet cleared the bank. Further research indicated that the checks were voided in the past, some later re-issued. Journal entry was then made to write off stale checks. Per FEC representative, Julie, inorder to report voided check, it must be entered in same line item in prior report as a negative amount to indicate that the check was voided. The voided checks were not reported individually because unable to determine line items where checks were previously reported under. Upon contacting FEC again regarding issue, representative Alexandra instructed that the total amount of the voided checks need to be reported on line 21b under the name of the bank where the checks were issued from with an explanation of discrepancy attached as memo because unable to locate prior reports and identify line items for checks that were previously reported.
