Dear Mr. Jones:

I am writing to provide what I hope is the final documentation needed to clear up your concerns from your letter of September 4, 2012. From our auditor, Maria Galdo, it is my understanding that the appropriate steps have been done by our campaign, save submitting this documentation.

As to the issue involving the United Food and Commercial Workers donation, enclosed you will find copies of both of their contributions. The first check, Check No. 400100 was dated March 6, 2012 and was noted for the Primary. The Ohio Congressional primary was on that date. The second contribution was via Check No. 400256, which was noted for the General Election 2012 and was dated and sent 55 days after that date. I have enclosed copies of both checks along with a notation as to their deposit.

It is also my understanding from Ms. Galdo that we need to deal with another over the limit contribution, this from an individual, Mr. Ronald Seavoy. Mr. Seavoy made a series of contributions, which exceeded the individual contribution limit by \$200. This last contribution was made on September 24, 2012. We immediately contacted Mr. Seavoy, informed him that he had exceeded the limit and sent him a refund via our check number 1200, a copy of which is enclosed. Mr. Seavoy left a voice mail for me indicating he did not "want the tax deduction" and to keep the funds and that he had destroyed our refund check. This check has not cleared.

I immediately contact Mr. Seavoy and tried to explain to him via email and voice mail message that this was not about a tax deduction, but the valid, federally mandated contribution limit and we issued Check 1206 on September 28, 2012 as a replacement. As of today, this

check has no cleared either. To rectify this situation, I am enclosing a cashier's check payable to the Federal Elections Commission for this refund. I am also enclosing copies of all check and correspondence on Mr. Seavoy to facilitate any investigation and resolution of this issue.
