RE: Amendments to 2008 Q2 FEC Form 3x

While preparing our 2008 3Q filing, I discovered an oversight in our 2008 2Q filing, and am submitting to you an amended form. I inadvertently failed to itemize a \$150 contribution which put the aggregate year to date contribution from this individual over the \$200 threshold for the year. This amendment clarifies that oversight.

The contributions were accounted for in the 2Q report as originally filed, so the total dollar figure of contributions made in the amended report are unchanged.

The amendments to the 2Q filing are as follows:

Line 11(a)(i) – Added \$150 to the itemized contributions in Columns A and B.

Line 11(a)(ii) – Subtracted \$150 from the un-itemized contributions in Columns A and B.

An additional Schedule A itemized contribution reporting page has been included.

In addition, a typo on line 20 Column B has been changed to accurately reflect the correct Total Federal Receipts (\$18,893.34 has been changed to \$19,893.34). This was a mistake in transcription only, and was not used to compute any of the remainder of the 2Q filing.

I apologize for the oversight on my part, and hope that this sufficiently clarifies the matter. Please do not hesitate to contact me if I can provide any further information or clarifications.
