This confirms receipt of your correspondence dated April 15, 2014 regarding the missing Summary Page to my year-end report (08/01/2013-12/31/2013).


I reviewed my copy of that report. The Summary Page is missing. I have enclosed the Summary. I appreciate your correspondence in that regard.






