1. Your committee has filed an amended Statement of Organization (FEC Form 1) to reflect a change(s) in your registration information. Please be advised that under 11 CFR §104.18(f), if a political committee files an amendment to a report that was filed electronically, the political committee shall submit a complete version of the report as amended, rather than just those portions of the report that are being amended. Further, 11 CFR §104.18(c) defines report as any statement, designation or report required by the Act to be filed with the Commission. Please provide a complete amended Statement of Organization to disclose the type of connected organization on Line 5(e).
2. Please clarify your relationship, if any, with "SOUTHWEST GAS CORPORATION POLITICAL ACTION COMMITTEE", which appears to be your connected organization. For further guidance on the question of connected organizations, please refer to 11 CFR §100.6. Also, you are advised that Line 6 should be used to disclose the name of your connected organization (not the apparent name of your PAC). Please amend your Statement of Organization to clearly identify the official name of your connected organization on Line 6.

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an



enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
