

Attached is the February 20th report for the NYNEX Employees' Federal Political Action Committee (PAC), Federal I.D. #C00179762. This report covers activity from January 1 thru January 31, 1995. The Cash on Hand balance on January 1 does not agree with the ending balance from December 31, 1994. This difference was found while reconciling the accounts and transferring the balances to our automated PAC system. The difference occurred while changing from a cash to an accrual system for recording receipts, and it affected the September 20th report and continued until the January 31st report. This overstated our account balance every month accumulating to \$4,886.01 at year end.


