The NRSC is in receipt of your Request for Additional Information dated August 17, 2015, referencing our amended April 2015 monthly report filed on 6/2/2015.

Commonwealth Digital Solutions bought out the NRSC's existing equipment lease with Xerox. The receipt of \$ 23,869.12 from Commonwealth Digital Solutions in connection with this buyout represented a prorated reimbursement to the NRSC for the payments made to Xerox in the amounts of \$ 5,967.28 on 3/16/2015 and \$ 21,711.72 on 3/31/2015.




