This letter is prompted by the Commission's preliminary
review of the report(s) referenced above. The review raised
questions concerning certain information contained in the
report(s). An itemization follows:

-The identification of each contributor, including the
person's occupation and name of employer, must be
provided if the person has contributed in excess of \$200
in the aggregate during the calendar year. Please amend
Schedule A supporting Line 11(a)(i) for each entry
lacking a contributor's occupation.


Note: If your committee has made attempts, either by a
written request or by an oral request documented in
writing to obtain this information from each
contributor, your committee may have exercised "best
efforts." Under revised 11 CFR 104.7(b), such effort
shall consist of an initial clear and conspicuous
request for the name, mailing address, occupation, and
name of employer of each individual who has contributed
over \$200 in the calendar year which informs the
contributor that the reporting of such information is
required by law. If necessary, your committee must make
a written follow-up request or an oral follow-up request
documented in writing, within thirty days with no
additional solicitation. Subsequently, the committee
should report any changes provided by the contributor or
any additional information which is in the committee's
records. If you believe that your committee satisfies

the "best efforts" provision, you should provide a copy of your solicitation or an explanation of the method(s) used to obtain contribution information. Clarification regarding "best efforts" should be disclosed during each two year election cycle beginning with the first report filed in the non-election year. 11 CFR §104.3(a)(4)(i)

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
