This letter is to inform you that as of August 28, 2002, the Commission has not received your response to our request for additional information, dated August 7, 2002. This notice requests information essential to full public disclosure of your federal election campaign finances. To ensure compliance with the provisions of the Federal Election Campaign Act (the Act), please respond to this request (copy enclosed).

An adequate response must be received at the Commission by September 18, 2002. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-In an electronic letter to the Commission you state, "Due to a data processing error, the contribution from Anne Derryberry was listed as \$10,000 instead of \$5,000. This contribution was allocated \$5,000 to the federal account and \$5,000 to the nonfederal account". However, the total amount of contributions from individuals/persons other than political committees disclosed on Line 11(a)(iii) has remained the same. Please provide clarifying information regarding this transaction and include the date(s) of the original deposit(s) in your account(s).

A response or amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
