In June of 1999, the Renal Leadership Council's (RLC) Political Action Committee (PAC) contributed \$2,000 to the "Robb for Senate" campaign.

We have been contacted by the Federal Elections Committee (FEC) and informed that the RLC PAC was not a "multi-candidate PAC" in June of 1999 and therefore could not legally contribute more than \$1,000 to the Senator for that election cycle.

Enclosed is a copy of the FEC letter for your records. The FEC states that the RLC PAC must ask for a refund of \$1,000 from "Robb for Senate" so that we can be in compliance with rules governing PACs that do not have "multi-candidate" status (Act. 2 U.S.C. §441a(a)).
