Thank you for sending your letter addressed December 21, 2006 concerning our need to file an amended FEC Report in reference to our Post-General Report dated 10/01/2006 – 10/18/2006. I truly appreciate your notification of the Federal Election Commissions concerns regarding the National Court Reporters Association's (NCRA) PAC compliance.

NCRA PAC discovered our mistake on the report that we filed originally instantaneously with the help of your analysts. Unfortunately, our PAC Manager entered in the incorrect dates for the report. Our PAC was not required to file the Pre-General Report due to the fact that we did not make any disbursements from our PAC during the specified time period. NCRA PAC was advised by our analyst to simply file the Post-General Report. Our PAC Manager was unaware that the dates on the report should have denoted a coverage period of 10/01/2006 - 11/27/2006. She entered in dates spanning 10/19/2006 - 11/27/2006 even though the report covered the time period from 10/01/2006 – 11/27/2006.
