In order for your organization to operate under separate contribution limits the rules at 11 CFR 110.3(b)(3) state that the committee must not have received funds from any other political committee established, financed, maintained, or controlled by and party unit; and that the committee does not make its contributions in corporation, consultation or concert with, or at the request or suggestion of any other party unit or political committee established, financed, maintained, or controlled by another party unit.

Please indicate whether your committee has received funds from a committee controlled by a political party.

An adequate response must be received at the Commission by October 3, 2001.

Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions for time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
