This memo is in response to the FEC letter dated May 20, 2015. The receipts in question totaling 25,604.18 from Martin Federal Credit Union, Achieva Credit Union, Railroad & Industrial Federal Credit Union, Florida West Coast Credit Union, GTE Financial Credit Union, Community First Credit Union, University Credit Union, South Florida Educational FCU, and Northwest Florida Chapter were contributions from credit union members and staff that did not meet the reporting threshold. In filing the report, we mistakenly reported the contributions on line 17 as Other Federal Receipts. Those receipts should have been reported on line 11 a iii as Unitemized Contributions from Individual/Persons. We have amended the year-end report to correct those mistakes.
