Dear Mr. Evans:

In response to your letter of April 3, 1996, we have re-added the totals from our 6/30/95 report (\$25,485) to our 12/31/95 report (\$37,6770) and find it does equal the \$63,255 as reported. There was a typographical error on column B of 6/30/95, but the amounts equal the total reported.

On Schedule A, we have re-added and checked the individual consolidated amounts on our contributors. We find them to be in order. Could you be more specific on your inquiry and we will be happy to check the amounts you have in question.

Regarding 2 USC §434(b) (3), we have reviewed 6/30/95 line 11(a)ii, added to 12/31/95 11(a)ii to find it equals the amount reported in column B. Our committee does not wish to list unitemized contributions on a separate schedule and will continue to list contributions that exceed \$200.00.

In regard to accepting a corporation contribution check, I have attached a copy of the check and letter received from the Wyoming Chiropractic Association PAC. Today we contacted by phone the Sec. Treasurer, Brett Ohman, of the PAC and he assures us these are PAC funds.
