-Line 18 of the Detailed Summary Page of your report discloses a total of \$310,250 in transfers from the non-federal account for joint activity. The sum of the entries itemized on Schedule H3, however, indicates the total to be \$250,250. Please amend your report to clarify the discrepancy.
