Dear Mr. Plouffe:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your original filing for the July Monthly report disclosed the receipt of \$500,000 on June 30, 1999 from the Democratic Leaders Victory Fund 2000, which is a joint fundraising committee affiliated with your committee. Your Amended July Monthly report indicates that a portion of the Memo Schedules itemizing this transfer are included in your Year End Report. A review of the Memo Schedules attached to your Year End report discloses a receipt date of December 31, 1999 for each itemized contribution. A receipt date of December 31, 1999 indicates that these contributions were received six (6) months after the receipt of the transfer from the Democratic Leaders Victory Fund 2000 and therefore cannot be considered the source of the original transfer. Please provide further clarifying information concerning these transactions and amend your report to clarify this discrepancy

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
