Please amend your report to provide the correct aggregate year-to-date totals. (11 CFR § 104.3(a)(2))
2. Your report discloses activity outside the coverage dates. This report should include only activity that occurred from 4/1/18 to 6/30/18. Please amend this report and any previous reports so that all activity is disclosed in the report covering the period in which the activity occurred. (52 U.S.C. §30104(b) (formerly 2 U.S.C. § 434(b)))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
