In response to your letter dated October 24, 2008 we enclose a faxed copy of a redesignation letter from the Coleman for Senate campaign. This letter was dated March 30, 2008 and would meet the 60 day rule for our March 6, 2008 contribution of \$4,000 which exceeds the limit by \$3,500. The letter includes a response form that, if returned, would generate a refund of the amount that exceeds the \$5,000 limit. If the form is not returned the Coleman campaign will redesignate the overage to his general campaign which in our case was what was done.

We will file an amended report that includes a memo entry listing this redesignation.
