Dear Ms. Benitz:

This is in response to your letter dated May 19, 2014 concerning the Year-End Report (12/1/2013-12/31/2013).

1. Schedule A line 12 of our October Monthly (9/1/2013-9/30/2013) report disclosed a "Repayment of Advance" totaling \$112 from "Braley Senate Victory," respectively, which is a joint fundraising committee affiliated with our committee. Schedule B supporting line 22 of the October Monthly (9/1/2013-9/30/2013) report disclosed the corresponding "Advance for Joint Fundraising Expenses" totaling \$112.

Schedule A of our 2013 Reports combined disclosed transfers totaling \$417,000 from "Reid Majority Fund," respectively, which is a joint fundraising committee affiliated with our committee. The sum of memo Schedule A was \$428,550, more than the amount transferred. Our April Monthly Report (3/1/2013-3/31/2013) Schedule A supporting line 12 reported memo entries from "Reid Majority Fund" totaling \$234,750 and our November Monthly Report (10/1/2013-10/31/2013) Schedule A supporting line 12 reported memo entries from "Reid Majority Fund" totaling \$193,800.

2. Schedule B supporting Line 28(a) disclosed a refund of a contribution made to the "Estate of Antha Billups." Antha Billups enrolled in a recurring contribution program on December 20, 2007 for an amount totaling \$10 per month. Recurring \$10 contributions were debited from her account monthly until November 20, 2013 totaling \$720. The recurring contributions did not itemize on our Schedule


