The services were provided from January 1, 2008, through March 31, 2008, pursuant to 2 U.S.C. 431(8)(B)(viii) and 11 C.F.R. 100.86. McDermott PAC records indicate an accidental payment of \$1,132.81 on April 5, 2007 to McDermott Will & Emery LLP for in-kind catering expenses; however, the transaction was not reported on the July 31 Mid-Year Report for 2007. Actual payment for these expenses was made to RSVP Catering on June 11, 2007, which was identified on the PAC's July 31 Mid-Year Report for 2007. On March 28, 2008, McDermott Will & Emery LLP reimbursed the PAC for \$1,132.81 for the accidental payment. The cash-on-hand balance for the PAC has not changed.
