Dear Ms. Sinram:

We are in receipt of your letter dated March 30, 2007 regarding the aforementioned report.

In regard to Schedule A for the contributions from Mr. Anthony Marnell and the respective partnerships, Austi LLC and MIII Holdings LLC. Please note we have added additional information for identity clarification, Mr. Anthony Marnell II in relation to the partnership Austi LLC, and Mr. Anthony Marnell III in relation to the partnership MIII Holdings. Therefore, both contributions are within the permissible individual limit and no excessive was incurred.

In regard to Schedule B Line 22 in regard to the corrective transfer for Mark Amodei, on 10/17/6. The original contribution was received and previously reported on 5/5/6 in the June monthly report.

In regard to the additional contributions and disbursements reported on this amended report from the original, during and internal review we identified inadvertent data entry errors that caused some receipts and disbursements to be reported as nonfederal to our state reporting, as well as some receipts and disbursements that were reported to our state reporting that should have been reported as federal. We have corrected these errors and filed the amendments accordingly. Additionally, we have implemented a system to cross check all entries of disbursements and contributions to ensure this will not recur.

In regard to Schedule B Line 30 for the disbursements of payments for the descriptions "Printing/Volunteer Exempt Mail". We have removed the "mail" portion of this description as no commercial mail vendor was used for distribution of these materials. This was all a volunteer driven effort. Additionally, these printed materials meet all of the requirements for exempt activity. Therefore no in-kind, independent expenditure or coordinated expenditure was incurred and there is no additional disclosure required.

In regard to Schedule A Line 12 for transfers received from the Republican National Committee, none of this money was used for any candidate specific or impermissible Federal Election Activities. For accounting purposes and to ensure the proper payments to vendors for services rendered, the all money received from the RNC is deposited into a designated specific account "Transfers". Prior to payment from any of our accounts, Operating, FEA and Transfers, each expenditure is reviewed for permissibility payment; payment is then made accordingly from the proper account.

In regard to Schedule H6, it appears our allocation percentage was transposed upon data entry. Accordingly we have corrected this on this newly amended reported and the subsequent reports that are affected by this. No corrective transfer is required in relation to this transposition as this was simply a computer entry error. Any transfers done were based on the proper allocation respectively 21% Federal 79% Levin/Nonfederal.

At this time our committee believes we are in compliance.
