

Engel for Congress. The \$2,000 contribution made on 10/17/00 should have been attributed to General 2000. This clerical error is corrected in the enclosed amended 12-Day Pre-Primary Report (10/01/00 - 10/18/00).

Schipske for Congress. The \$5,000 contribution made on 10/13/00 should have been attributed to Primary 2000 debt. This clerical omission is corrected in the enclosed amended 12-Day Pre-Primary Report (10/01/00 - 10/18/00).

Carson for Congress. One \$5,000 contribution made on 10/10/00 should have been attributed to Primary 2000 debt. The other \$5,000 contribution made on 10/10/00 should have been attributed to the 9/19/00 Run-off Election debt.
