This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 3 items:

1. Please provide the totals for Line 6(a), Column B and Lines 8, 11(a)(iii) and 11(d), Columns A and B of the Summary and Detailed Summary Pages. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.
2. Your calculations for Line 6(d), Columns A and B appear to be incorrect. FEC calculations disclose this amount(s) to be \$2,520.53. Please provide the corrected total(s) on the Summary Page.
3. The Summary Page discloses \$1,857.88 on Line 7, but the Detailed Summary Page shows the Line 31 total to be \$662.65. These figures should be the same. Please amend your report accordingly.

-It has come to the attention of the Federal Election Commission that the reports you have filed during the current election cycle do not reflect the appropriate coverage dates for quarterly filing status. Please be advised of the filing dates and coverage periods for the 2009-2010 election cycle and fill in the appropriate dates on Line 5 of the Summary Page.
