As indicated in AA PAC's February Monthly Report and per the FEC Request for Additional Information dated March 3, 2016 an overpayment in the amount of \$4806.70 was mistakenly paid to AA PAC for January PAC payroll deductions. See Feb. Monthly report... Sch. A, Line 17. In order to take corrective action, an investigation into the cause of the mistake was undertaken and it determined that the overpayment was the result of human error not a technological malfunction. Specifically, the corporate employee responsible for the executing the transfer of PAC funds inadvertently authorized duplicate transfer, which resulted in the overpayment. To correct the error a refund of the overpayment has been requested and is being processed by the PAC's bank. The refund will be disclosed on AA PAC's next monthly report.
