We take this matter very seriously and have taken the necessary corrective action. In accordance, our specific activity in response to the 4 items outlined in your letter was as follows:

1. On July 9, we cut checks from AMBUPAC refunding excessive funds to Ms. Jamie Pafford-Gresham for the amount of \$2,800 and Mr. Tyron Picard for the amount of \$100. On July 10, the checks were sent to Ms. Pafford-Gresham and Mr. Picard. Photocopies of the checks are enclosed with this letter.
2. On July 10, we submitted electronically an amended report with the proper itemization of receipts previously identified as "Cash from 2007, Cash."
3. On July 10, we submitted electronically an amended report with the occupation and employer for those individuals who previously did not have that information disclosed.
4. On July 10, we submitted electronically an amended report with "American Medical Response" instead of "AMR" as the name of the employer for those employees with that company who contributed to AMBUPAC.
